Active Duty LAMS Classes

For those Auxiliarists that can attend, the 5-day Active Duty LAMS class is an excellent learning opportunity. We encourage all members to attend. Most Active Duty LAMS classes are unfunded; no reimbursement for expenses is authorized.

The process for registering for a class is as follows.

- a. **For Units, Sectors, AIRSTAs, Cutters, etc.** – Call the POC and express interest in attending the class, and request a seat. While preference is given to active duty, most classes will have capacity for Auxiliarists.
- b. **For Resident Classes (held at the USCG Academy, TRACEN Yorktown and TRACEN Petaluma)** – Submit an STTR through your FC to your DIRAUX for approval by the Training Quota Center (TQC) office. Because these locations are major Coast Guard Training Centers and have berthing available, these classes are centrally scheduled by TQC.
- c. **Local Area Classes** – These classes are scheduled if the local area can support a class. These classes may or may not be on the Master Schedule. If you are notified of a Local Class, follow the process for Units, Sectors, AIRSTAs, Cutters, etc. outlined in (a.).

To Receive Credit for Attending the Course in AUXDATA:

It is the sole responsibility of the student to ensure that they receive credit for attending an Active duty LAMS course by following this procedure:

- a. Make a copy of the Course Completion Certificate (or scan the Certificate into electronic format) and send to the SO-IS or FSO-IS (depending on who does your data entry) and request that they enter it into AUXDATA.
- b. Send a copy of the Course Completion Certificate to your DIRAUX and request that a hard copy be put into your personnel file.
